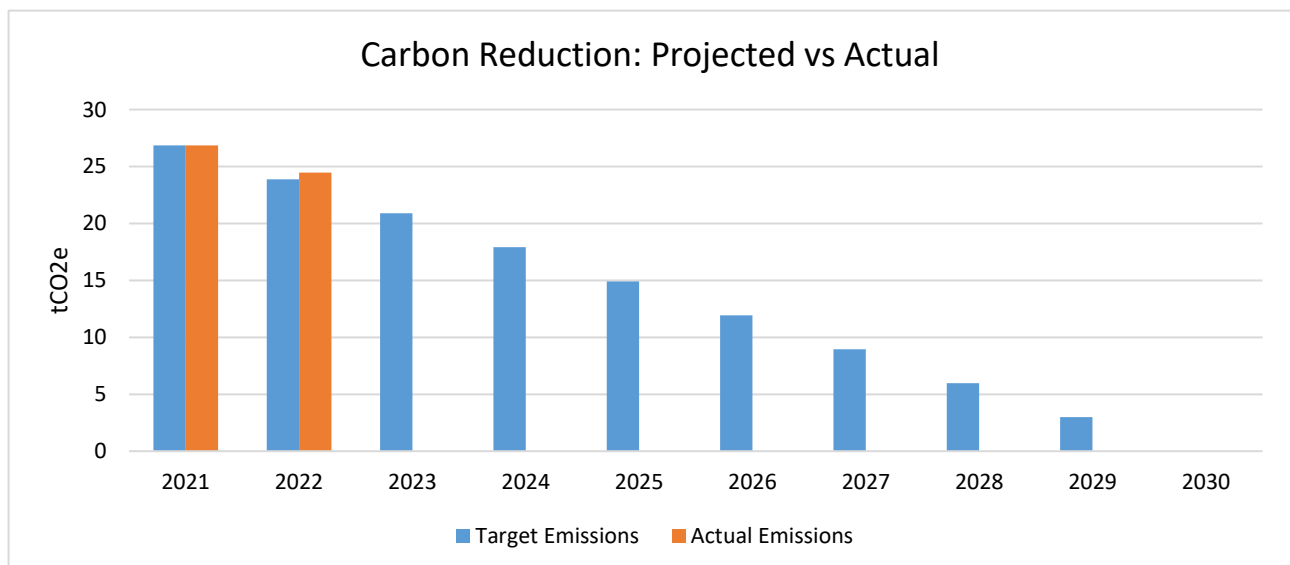

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 11.9 tCO₂e by 2026. This is a reduction of 55.6 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the baseline and the measures will be in effect when performing the contract. The carbon emission reduction achieved by these schemes equate to 2.4 tCO₂e, a 8.9% reduction against the baseline.
